 - ▶ Tick the Categories you wish to enter. You can choose to enter up to four categories.
 - ▶ Send the form to us asap to register your intention to enter the awards. Email the form to us at enter@thenegotiatorawards.co.uk.
 - ▶ You then need to write a separate supporting statement for each entry. This should be a maximum of ten sides of A4, supplied as a single PDF, no larger than 15MB.
 - ▶ As soon as you can, and in any case before the entry deadline of 30th June 2018, send us your supporting statements as separate PDFs. You must include your Entry Form. Send your submissions and forms to us by email at enter@thenegotiatorawards.co.uk
